Instructions:

1. Ensure your major/minor declaration(s) are accurate by reviewing Self-Service/Student Planning. If updates are needed, submit the Major/Minor Declaration form found on the Office of the Registrar's website.
2. Review your progress in Student Planning. List all of the courses you still need to complete in remaining semesters for your degree(s) below, including the semester you plan to take each course. Include elective credits within the elective credits section.
3. Include outstanding incomplete and/or in progress (grades of I or IP) courses. Include grade for any completed courses.
4. Specify ALL courses approved as substitutes and the course they are substituting. Include any course previously taken or to be taken and transfer credits from other institutions that may be used as a substitution to satisfy a requirement.
5. Indicate courses that you may transfer from another institution to satisfy remaining degree requirements.
